In accordance with Chapter 2 Section 2-182 of the Town of North Smithfield Code of Ordinances, as amended, we, the North Smithfield Juvenile Hearing Board

The North Smithfield Juvenile Hearing Board met in 2018 to review a total of 11 cases involving juveniles charged with first misdemeanor offenses.

The Juvenile Hearing Board issued a total of 22 sanctions during this time. The number of sanctions exceeds the number of cases because often more than one sanction was issued for a single offense.

The juveniles that were seen before the Juvenile Hearing Board seven males and four females. Three juvenile were sent to family court.

Sanctions Include: Three essays/sentences
Four letters of apology
One referred to counseling
Seven Report card
One curfew
Three other assignment were, researching, definitions, and reading list goals

.The Juvenile Hearing Board looks forward to continuing its service to the town and the youth of North Smithfield in 2019.

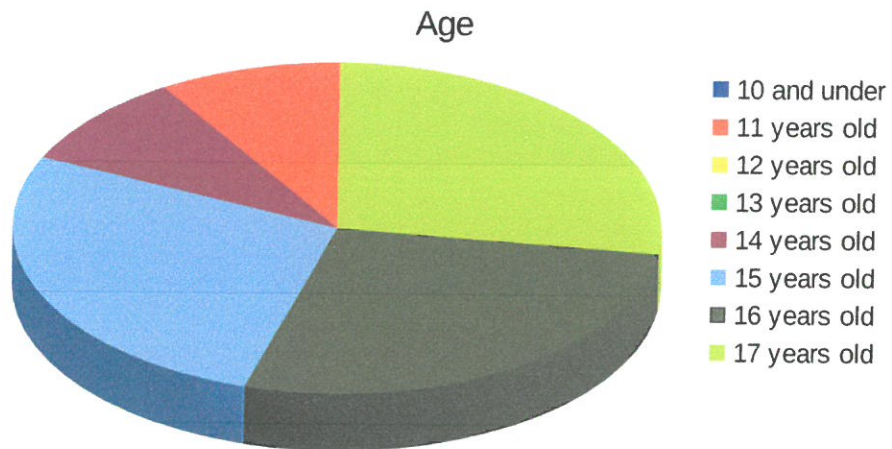
