In accordance with Chapter 2 Section 2-182 of the Town of North Smithfield Code of Ordinances, as amended, we, the North Smithfield Juvenile Hearing Board, respectfully submit the following annual report.

The North Smithfield Juvenile Hearing Board met in 2016 to review a total of 3 cases involving juveniles charged with misdemeanor offenses. All of the cases were for trespassing.

The Juvenile Hearing Board issued a total of 8 sanctions during this time. The number of sanctions exceeds the number of cases because often more than one sanction was issued for a single offense. The majority of the sanctions were written letter of apology at (100%) completion. The community service was performed at a location in North Smithfield.


Other sanctions include essays/sentences researching or reflecting upon the outcome of the youth's offense (33.33%), letters of apology (100%), counseling or referred to counseling (33.33%), report cards (66.67 %), and community service (33.33%).

Out of the completed sanctions required of the juveniles (100%) were completed.

The juveniles that were seen before the Juvenile Hearing Board were one female at the age of 17 years old and two males at the age of 16 years old.

The Juvenile Hearing Board looks forward to continuing its service to the town and the youth of North Smithfield in 2017.
