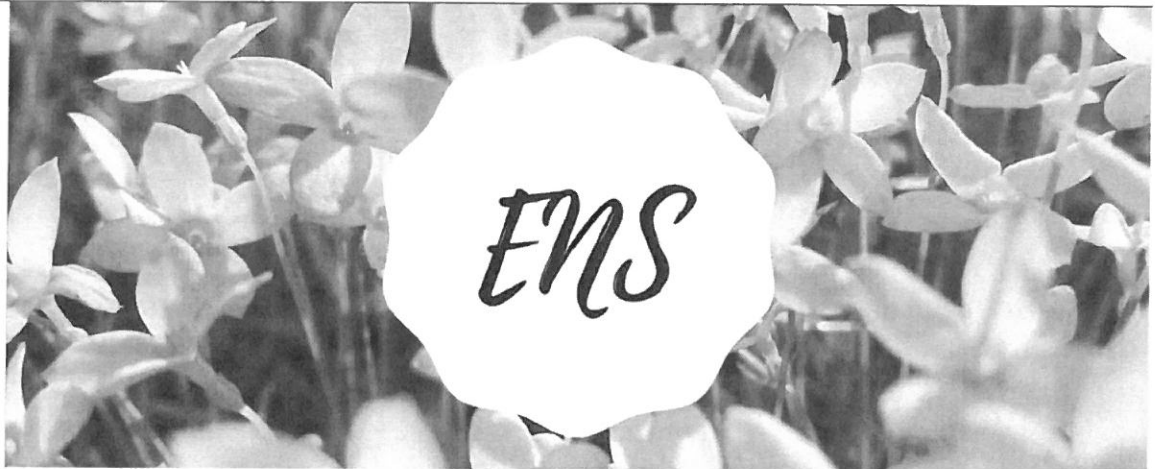

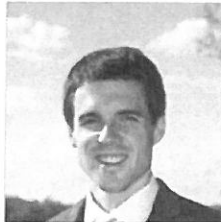

David M Gold Gary Palardy ...it is okay to disagree. We all know the current law on the books - gold could not be mined in not too distant past US history by law either, but look at it now. Removing gravel, for the near or distant future possibility, in eskar form does NOT require mining, blasting or such...simple removal from outcropping of formations formed around the ice age. Once removed the land left is again flat as was once the case. In terms of value for appraisal purposes, Federal Law Uniform Standards of Appraise Practices ("USPAP") requires the appraiser to state the presence of any/all positive or negative presences to effect value (negatives would include arsenic in the ground, for example) to be noted in a certified, USPAP approved appraisal. I am past President of the Boston ASA (American Society of Appraisers) as a background for my statement(s).
