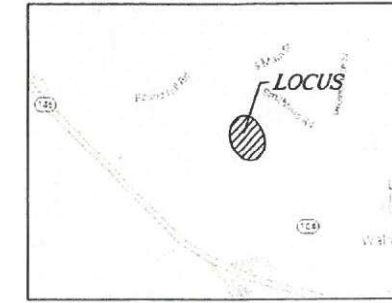


# General Notes
